### **Landscape discussions:**

--Common area in back of 45-51. Has been tabled for now. Anyone is welcome to go back there; it's common area.

--Bottom of hill plants around sign for LSM. Tiffany (Fixhers) will cut back viburnum and other plants and move some plants on 2/26. Also, on east side of Brown St. entrance—viburnum and boxwood maintenance. We agreed to cap her at 10 hours.

--West side of Brown St. across from signage and heading up hill. Leland cypress must be trimmed back, and Scott at Arborcare will do it @\$1800 for a day. then see if we need him another half day.

**--Motion made and seconded that we trim cypress this year and look at long-term plan next year. Motion passed with majority.**

--Peter Stanz requested we take a look at long-term plan b/c Leland cypress get diseased. Should they be cut down or what is the solution? Barbara will recommend long-term plans with Arborcare's expertise.

--Aaron to take care of overhead vines/trees and general maintenance-mowing, trimming, mulch.

--Katerina will do weeding in common area.

### **Budget discussions:**

--We have \$2600 in budget from 2025 and \$300 extra from storm drain.  
--We will transfer \$600 to cover common area expenses. Martha to send out amended budget. This should cover the Leland cypress trimming.

Please pay 2026 assessments ASAP.

**Board position discussions:**

—Gene Adams joins BOD as a member. Deb Davis also joins BOD. Scott Petrucha will be Secretary. Other members include Verdine Spicer, Sharon Spry and Jeff Winston.
